Overview of the project:

Sustainability has become an important issue in Canada and globally, and educational developers (EDs) are increasingly asking for assistance in how to incorporate Education for Sustainability (EfS) into their practices. In response, the EDC EfS Action Group was formed in 2013 with a mandate to advance knowledge of the interrelation of environmental, social and economic sustainability topics and pedagogies in teaching and learning within higher education. The three principal investigators, who are members of this group, have found that Canadian EDs want more guidance about how to integrate EfS into their practices, especially using evidence-based approaches.

Presently, sustainability themes are embedded within teaching and research primarily when sustainability is a personal interest of the educator or educational developer. We have identified a need for a more considered and structured approach to integrating sustainability themes, pedagogies and learning outcomes within teaching and learning.

Or aim was to draw out practices of EfS in ED to stimulate and support EDs to incorporate EfS into their practices. We set out to gather practice cases through interviews with expert EfS practitioners and share the results through appropriate websites. We also planned to conduct a literature review in EfS in ED.

We completed the following:

- Interviews using Skype were conducted with 10 people who support faculty in the area of EfS. These interviews were recorded using Ecamm Call Recorder. To keep the project to a manageable size, we focused on national rather than international practitioners; our interviewees all worked at Canadian institutions.
- A website was created to share results of the interviews as openly available resources, and is linked from several other websites including the EDC EfS Action

Group, George Brown College Research and Innovation, the Resource Repository for Sustainability and Leadership, and the UBC Sustainability Initiative. Resources on the website consist of:

- Video clips from the interviews,
- Summary transcripts of the interviews.
- A literature review of EfS in ED was started, and we hope to complete it in the future.

Educational findings/outcomes

- The interviews demonstrate a wide diversity of ways in which EDs contribute to EfS, at the institutional level, faculty/department level and course level.
- From the interviews, we have made available a set of video clips and summary transcripts that highlight these practices, and in turn how the EDs support post-secondary teachers to embed sustainability themes, pedagogies and outcomes into their courses and programs.
